BID TO STRENGTHEN PARTY ORGANISATION Nadda to visit Bengal in June amid desertions, infighting in state BJP

BJP NATIONAL president JP Nadda is likely to visit West Bengal in June to take stock of the party's organisational affairs at a time when party leaders are deserting to the state's ruling Trinamool Congress (TMC). Nadda will lead a two-day trip to the state starting on June 7, it is learnt.

He is scheduled to hold organisational meetings, besides chairing separate meetings with party MPs and MLAs. He will also preside over the first working committee meeting of the new state party unit in Bengal.

Nadda's visit assumes significance as party MP Anuj Singh recently returned to the TMC, dealing a massive blow to the saffron camp in the state. The state unit of the party is also struggling to deal with the infighting between several camps with party old-timers training their guns on newcomers for the current situation.

The BJP national president's focus will be on holding on to the number of party MPs and MLAs in the state ahead of the September election.

Party national vice-president Dilip Ghosh said, "Nadda ji had said that he would come to Bengal. This is mainly a tour to strengthen the party organisation."

In an attempt to strengthen the party's booth-level organisational set-up, Dilip Ghosh has

been given the responsibility to monitor the situation in Bihar, Jharkhand, Manipur, Meghalaya, Assam, Odisha, Tripura and Andaman and Nicobar Island. He was asked to do so by Nadda after an internal party meeting in Delhi.

Sources said the decision was aimed at engaging Ghosh in other states while leaving the task of managing the party affairs in Bengal to the new state leadership under Sukanta Majumdar.

Majumdar, who was made the state unit president in September last year while Ghosh was retained in the post of national vice-president.

When contacted, Majumdar said, "Ghosh is a leader from Bengal and is credited for building the party organisation here. He is now given the responsibility to work outside Bengal. This is quite normal."

Ghosh had criticised the new state leadership over "lack of experience".

Meanwhile, Leader of Opposition in state Assembly Suwendu Adhikari held an organisational meeting in Barapokra to restructure the party in the wake of MP Anuj Singh leaving the party.

Adhikari was made in-charge of the party's Barapokra district unit.

Eying 2024, BJP ministers to visit seats lost in 2019

STEEPING UP preparations for the next Lok Sabha elections, the BJP on Wednesday asked its Union ministers to visit more than 140 constituencies across the country, where the party could not win in the 2019 elections, and interact with party workers and beneficiaries of government welfare schemes to boost the party's chances.

The ministers are expected to launch their electioneering work during the next week to mark eight years of the Narendra Modi government, sources said. Party lawmakers have been asked to visit the constituencies in 25 batches over the next two weeks by 10 party workers.

"Thus, the party will see that at least 77,800 booths are strengthened in terms of activities and presence wherever the party has to get into massive election programmes, there will be a special team of four leaders to take charge," said a source.

During a meeting with Union ministers at the party headquarters, both Home Minister Amit Shah and BJP president JP Nadda urged them to intensify the outreach programmes ahead of the 2024 elections.

The meeting also discussed the programmes for the Modi government's eighth anniversary celebrations. The most significant programmes will be communicating to the people about the "effective implementation" of the welfare schemes

for the poor and weaker sections. BJP sources said the party will be targeting women and beneficiaries of the government welfare programmes as well.

The ministers were asked to hold multiple press conferences and campaign programmes to explain the Modi government's initiatives to ease the inflationary pressure — an outcome of global situations such as increase in prices of crude oil and the Russia-Ukraine conflict — on the common people. The government has already announced a reduction in excise duty on petrol and diesel by Rs 6 per litre and a 5 per litre respectively. It has also reduced customs duty on raw materials and intermediaries for plastic products and iron and steel. With these and other measures, such as curbs on wheat and sugar export, the government has addressed the major concern — price rise — the sources said.

Five Bengal trekkers among six killed in Uttarakhand

New Delhi: Six people, including five trekkers from West Bengal, were killed on Wednesday when the SUV they were travelling in fell into a gorge and caught fire in Tehri district.

The mishap took place near Kotigand on the Rishikesh-Gangotri highway when the SUV, carrying a team of trekkers from Haridwar to Kedarnath-Gangotri, fell into the gorge, said District Magistrate AV Ashish Srivastava. The vehicle fell into a 50-metre-deep gorge and burst into flames in which all the six occupants of the vehicle, including the driver, were charred to death. A magisterial probe has been ordered to ascertain the cause of the accident, he said.

Chief Minister Pushkar Singh Dhami, who was on a visit to Pithoragarh to inaugurate some development projects, was also on the foundation stones for some of others, expressed grief at the loss of lives in the accident.

The deceased were identified as Madan Mohan, Bhuvan Singh, his wife Jhumnika, their sons Nilesh and Pradeep Das, Devnalya Devi and driver Ashish. PTI

## Decision on political foray likely by end of May: Naresh Patel

EXPRESS NEWS SERVICE RAJKOT, MAY 25

A DECISION ON his political plunge will likely be taken by the end of this month, said Patidar leader Naresh Patel in Rajkot Wednesday.

"The question before me is if I should join politics in the first place. Second, if I take a plunge in electoral politics, what party should I join? I am still considering these issues and should be in a position to announce my decision tentatively by May 31," Patel, the chairman of Shree Khodalham Trust (SKT), said during a dinner he hosted for media persons of Rajkot.

Incidentally, Patel had previously said that the BJP Congress and Aam Aadmi Party (AAP) have all extended their invitations to join their ranks.

However, the influential Patidar leader who has organised Leuva Patidar sub-caste group of Patidar community is yet to make up his mind even though he has asserted in the past that youth and women of

the society want him to join electoral politics.

Patel's statement comes in the run up to Prime Minister Narendra Modi's scheduled visit to Atkot village in Rajkot district on May 28 for inaugurating KD Parvadiya Multi Speciality Hospital. The Rs-40-crore hospital has been built by Patel Seva Samaj, a charitable trust run by the Patidars and in which Bharat Boghra, vice-president of BJP's state unit, is the managing trustee. However, Patel said he would not be able to attend the Akot event. "I have prior commitments," he said.

## HC denies bail to accused in Ram Navami clash in Himmatnagar

THE GUJARAT High Court on Wednesday rejected the regular bail plea of an accused in a clash that broke out in Himmatnagar city of Sabarkantha district on Ram Navami last month.

The accused, Prakash Pandya, was part of a procession that was taken out to celebrate the festival

on April 10 and he was purportedly seen wielding a sword in a CCTV grab.

The procession was attacked, triggering a communal clash after which FIRs were lodged for rioting.

Justice Samir Dave rejected Pandya's bail plea at the admission stage and directed the petitioner to approach the court after a chargesheet is filed in the case.
