Notice of Annual General Meeting and e-voting
 Notice is hereby given that the 24th Annual General Meeting of the Members of the Company (the "AGM") will be held on Monday, August 14, 2023 at 03:30 PM (IST) through Video Conferencing ("VC"/"Other Audio Visual Means" ("OAVM")), to transact the business set forth in the AGM Notice dated July 18, 2023.

In accordance with the General Circular dated May 5, 2020 read with General Circular dated April 8, 2020, April 13, 2020, May 5, 2020, January 13, 2021, December 8, 2021, December 14, 2021, May 5, 2022 and December 28, 2022 issued by the Ministry of Corporate Affairs and Circulars dated May 12, 2020, January 15, 2021, May 13, 2022 and January 5, 2023 issued by the Securities Exchange Board of India ("SEBI"), the Notice of AGM and Annual Report including the Audited Financial Statements for the financial year 2022-23 have been sent in electronic mode to Members whose email IDs are registered with the Company or the Depository Participant(s). The electronic dispatch of Annual Report and the Notice of AGM to Members has been completed on July 21, 2023.

In compliance with the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended, and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company is providing the facility to all its Members holding shares either in physical or in electronic form to exercise their vote on the resolutions proposed to be considered at the AGM by electronic means through e-voting platform ("remote e-voting") provided by National Securities Depository Limited ("NSDL"). Further, it is also notified to the Members that:

a) The remote e-voting period begins on Friday, August 11, 2023 at 09:00 AM (IST) and ends on Sunday, August 13, 2023 at 05:00 PM (IST). During this period, Members of the Company holding shares either in physical or electronic form, as on the Records Date cut-off date i.e. Monday, August 7, 2023 may cast their vote through remote e-voting.

b) A person, whose name appears in the Register of Members/Beneficial Owners as on the cut-off date i.e. Monday, August 7, 2023 will be entitled to avail the facility of remote e-voting for e-voting during the AGM. The voting rights of Members shall be in proportion to the number of shares of the Company held by them as on the cut-off date.

c) The remote e-voting shall not be allowed beyond 05:00 PM (IST) on Sunday, August 13, 2023.

d) Copy of the Annual Report for the year ended March 31, 2023 and the Notice of AGM inter alia indicating the process and manner of remote e-voting/e-voting have been sent by electronic mode to those Members whose email addresses are registered with the Company/Depository Participant(s) on July 14, 2023.

e) Annual Report for the year ended March 31, 2023 and the Notice of AGM are also available on the website of the Company www.wockhardt.com.

The Notice of AGM is also available on the website of NSDL at www.evoting.nsdl.com, on the website of BSE Limited (www.bseindia.com) and National Stock Exchange of India Limited (www.nseindia.com), where the equity shares of the Company are listed.

f) Any person, who becomes a Member of the Company after despatch of the Notice of AGM and holding shares as on the cut-off date i.e. August 7, 2023, may obtain Login ID and Password for e-voting by sending a request to evoting@nsdl.com. If the Member is already registered with NSDL for remote e-voting, then he can use his existing User ID and Password for casting the vote through remote e-voting. For details related to remote e-voting, please refer the Notice of AGM.

g) The Members who cast their vote through remote e-voting shall be eligible to attend the AGM. But shall not be allowed to cast their vote again at the AGM. The Members who have not cast their vote by remote e-voting shall be eligible to attend the AGM and cast their vote during the AGM.
